New Amsterdam Capital Approved as Listing Sponsor for Alternext Brussels

New Amsterdam Capital (“NAC”), the specialist investment firm, has been approved as a Listing Sponsor for companies seeking to list on NYSE Alternext Brussels. Alternext is an exchange regulated market operated by NYSE Euronext that operates in Brussels, Paris, Amsterdam and Lisbon designed to attract smaller fast growing companies seeking a public listing.

Since Alternext was inaugurated in 2005 in Paris, over 120 companies have launched their initial public offerings on this market. The Brussels arm of Alternext was launched in 2006.
